**Summary:** The Early Head Start Visitor will provide early, continuous, intensive and comprehensive child development and family support services to eligible pregnant women, infants, toddlers and their families through a series of weekly home visits 90 minutes each and scheduled socialization activities. The EHS home visitor will design, plan and carry out developmentally appropriate experiences that meet all component areas of Head Start, the school readiness goals established by the program and the individual needs of the child. Each Home Visitor will maintain a maximum caseload of 10-13 infants/toddlers and/or pregnant women. While working in the Early Head Start home visiting program you must be able to incorporate the seven teachings into your work with families.

### Essential Duties and Responsibilities include the following.

- Establish a trusting and caring relationship with each child and his/her family.
- · Serve as an advocate between community resources and Early Head Start families
- Provide home visits and socialization experiences to promote, enhance, and monitor the development of each enrolled child.
- Partner with the family to develop self-sufficiency goals for the child and family.
- Assist families in identifying family resources and needs.
- · Support family empowerment, involvement in the program, and positive family relationships.
- Model positive self-esteem building behaviors when working with the family.

• Partner with parents and families as they become life-long educators by observing, guiding, promoting and participating in the everyday learning of their children at home, school, and in community.

## **Education and/or Experience:**

## **Required:**

Must have CDA home-based credential or comparable credential, or equivalent coursework as part of an associate degree, with Associates Degree in Early Childhood Education within two years.

## Preferred:

- Must be willing to incorporate Ojibway language into lesson plans when working with children and families.
- Experience in the early childhood field preferred.
- · Knowledge of Parents as Teachers curriculum preferred.
- Must have knowledge and experience in child development, principles of child health, safety and nutrition,

adult learning principles and family dynamics.

- · Must possess good organizational skills with sensitivity to details and confidentiality.
- Must be able to effectively plan, organize and implement educational activities and be non-resistant to change.
- Must be able to work as a team to provide services to families.
- · Must comply with all state licensing requirements and Head Start Performance Standards.

#### **Other Skills and Abilities:**

#### **Required:**

Must be willing to acquire technology competencies. Must have a valid driver's license meet eligibility for tribal insurance. May be required to lift up to 50 pounds at times.

#### **Background Check:**

This position is contingent on the required ability to pass a caregiver background check when working with children. This position required for eligibility required driver check, to meet eligibility for Tribal Insurance.

**Qualification Requirements:** To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed are representative of the knowledge, skills, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

#### **Physical Demands:**

Must be physically able to make home visits. Position requires some walking, standing, bending, stooping and occasional lifting to 50 lbs. Subject to inside and outside working conditions.

**Working Environment:** The noise level in the working environment is usually moderate to loud. Subject to inside and outside weather conditions. Work environment includes the Bad River Head Start/Early Head Start, transports to local clinics, client homes or community locations.
