Summary: The Bad River Band identified access to treaty-harvested foods and support for local food systems as top priorities in its 2018 Strategic Plan to address persistent food insecurity and high rates of premature death due to diet-related disease. The Bad River Tribe's Local Food Purchase Assistance Cooperative Agreement (LFPA) Program is designed to provide low-income tribal members with access to high-quality, locally sourced food, including indigenous foods produced in the Great Lakes region. The Local Food Purchasing and Distribution Specialist will support the procurement of local foods from programs including the Tribal Elder Food Box Program, and tribal and non-tribal food producers in the Chequamegon Bay area, and coordinate the distribution of food to community members.

Essential Duties and Responsibilities include the following. Other duties may be assigned.

- Ensure the fulfillment of the Tribe's obligations pursuant to its cooperative agreement with the USDA on LFPA, coordinating with other programs and departments as necessary.
- Develop an overall program plan and policies for the procurement of foods through LFPA funding, prioritizing the purchase of food from indigenous, socially disadvantaged, and local producers, and developing specific policies related to pricing and food safety; present plans and policies at Tribal Council meetings for modification and approval.
- Develop a distribution plan for the food purchased by the Bad River LFPA Program, including criteria for participation and the expected amount, and types of food, each family or recipient will receive for approval by the Tribal Council.
- Participate in and take an active role in leading monthly Food by Prescription meetings.
- Coordinate the procurement of local foods from and with other programs such as Hunger Task Force, the Tribal Elder, and Community Food Box Program, etc., and from tribal and non-tribal food producers in Wisconsin and within 300 miles of the Bad River Reservation, prioritizing tribal producers based in the Chequamegon Bay area and traditional foods.
- Utilize Local Food Market Place storefront for food distribution and reporting.
- Coordinate promotional events to teach and provide traditional and local foods, including recipes, and samples.
- Distribute food purchased by the Bad River Tribe's LFPA Program, coordinating with other departments as necessary.
- Administrative duties related to procurement and fulfilling grant reporting requirements.
- Maintenance of the Fish House includes securing any necessary contract work, keeping a clean and sanitary environment.

**Qualification Requirements:** To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed are representative of the knowledge, skills, and/or ability required. Knowledge of the uniqueness of the Bad River Community. Reasonable accommodations may be made to enable individuals with disabilities to perform essential functions.

**Required:** 

- High School Diploma or equivalent
- Relevant employment experience and/or volunteer experience in small-scale agriculture, traditional food production, purchasing, or other related fields.

### **Required Eligibility:**

Driving. This is a required driver position. Must hold and submit a valid Wisconsin driver's license, a reliable vehicle with state-required minimum liability insurance, and meet the criteria to be placed on the Bad River Indian Tribe's approved required drivers list. Must be able to travel out-of-town and for infrequent overnight trips.

**Background Check:** This position is required to pass a general background check and for eligibility to meet driver requirements.
