## REQUEST FOR PROPOSALS FOR Electrician for Ursula's Farm

Bad River Band of Lake Superior Tribe of Chippewa Indians is seeking proposals through solicitation for:

- Installing Permanent 200 amp Underground Electrical Service including:
  - A meter box
  - 8 additional circuits
  - A wooden pedestal
  - 2 x 20 amp GFCI duplex outlets w/ in-use covers
- All work must comply with the National Electrical Code and Wisconsin Electrical Code.
- All work must follow Xcel Energy Design for SC-50 found in Xcel Energy Standard for Electric Installation and Use.
- The electrician is responsible for all inspections and permits.

Proposals are required to contain the following information:

- Total Cost
- Valid, current electrical license

The Bad River Band of Lake Superior Tribe of Chippewa Indians is a federally recognized Indian Tribe organized under Section 16 of the Indian Reorganization Act of 1934, U.S.C. Section 476. This entitles the Tribe to government pricing and exempts the Tribe from state sales and use taxes and from federal excise taxes. Therefore, price quotations should not include such taxes.



This Request for Proposals is open to all qualified, responsive bidders. Indian Preference will apply in the selection process in accordance with the Tribal Employment Rights Ordinance (TERO) or the Indian Preference Act of 1934 (Title 25, USC, Section 47), based on funding source requirements. Questions regarding TERO, and if the TERO fee applies to the RFP, may be directed to the Bad River Band's Human Resource office at 715-682-7111. Firms or persons applying for Indian preference must provide evidence in its proposal of 51% or more Indian ownership. In addition, the firm or person must provide evidence of structure, management and financing affecting the Indian character of the firm. Documentation of and compliance with Indian Preference must accompany the proposal.
