## Request for Proposals

**Abinoojiiyag Road Culvert Replacement and Reditching**  
Bad River Band of Lake Superior Chippewa Tribe of Lake Superior Chippewa Indians  
Odanah, Wisconsin

Bad River Band of Lake Superior Chippewa Indians is seeking proposals through solicitation of a number of sources for a construction project consisting of replacing a culvert under Abinoojiiyag Road. Project will consist of grading, drainage, aggregate base, culvert replacement, and bituminous surfacing as identified in Attached Bid Packet.

**Bid Information:** Complete bid information and specifications are included in the Bid Packets. Bid Packets can be obtained by contacting Ben Connors, contact information is below. **All prospective bidders are asked to read the "General Plan Notes" section of the project plans carefully before filling out and submitting a bid schedule.**

Proposals are required to contain the following information:

- A lump sum (or total) cost of the proposed contractual services;
- A completed bid schedule showing the itemized costs of the project;
- A proposed project schedule;

If a proposal is submitted that does not contain all of the required information, then the proposal will be deemed incomplete and will not be further considered in the evaluation of proposals.

Proposals will be evaluated on the following factors:

- Proposal completeness;
- Project cost;
- Project schedule;

The Bad River Band of Lake Superior Chippewa Indians is a federally recognized Indian Tribe organized under Section 16 of the Indian Reorganization Act of 1934, 25 U.S.C. Section 476. This entitles the Tribe to government pricing and exempts the Tribe from state sales and use taxes and from federal excise taxes. Therefore, price quotations should not include such taxes. This project is funded through FHWA and The Bureau of Indian Affairs.

Performance Bond of 100% of contract


The Bad River Tribe's purchase/contracts shall be made in accordance with the subcontractor's provisions of the P.L. 93-638 contract.
