REQUEST FOR PROPOSALS FOR The Supply and Delivery of a Garbage Truck

The Bad River Band of Lake Superior Tribe of Chippewa Indians is seeking proposals through solicitation for the following work:

- Supply and delivery of an 8 cubic yard garbage truck.

The selected firm will contract directly with the Band for services rendered. Proposals for the performance of work are due no later **10:00 AM CT on Thursday, March 12, 2026** and should be submitted as sealed bids via Certified U.S. Mail or personal delivery to the address below.

The Bad River Band of Lake Superior Tribe of Chippewa Indians is a federally recognized Indian Tribe organized under Section 16 of the Indian Reorganization Act of 1934, U.S.C. Section 476. This entitles the Tribe to government pricing and exempts the Tribe from state sales and use taxes and from federal excise taxes. Therefore, price quotations should not include such taxes.

This Request for Proposals is open to all qualified, responsive bidders. Indian Preference will apply in the selection process in accordance with the Tribal Employment Rights Ordinance (TERO) or the Indian Preference Act of 1934 (Title 25, USC, Section 47), based on funding source requirements. Questions regarding TERO may be directed to the Bad River Band's Human Resource office at 715-682-7111.

Firms or persons applying for Indian preference must provide evidence in its proposal of 51% or more Indian ownership. In addition, the firm or person must provide evidence of structure, management and financing affecting the Indian character of the firm. Documentation of and compliance with Indian Preference must accompany the proposal.

- I. General Information: The Bad River Band of Lake Superior Chippewa Indians is soliciting quotes for the supply and delivery of an 8 cubic yard garbage truck. Delivery of the equipment shall be to the Solid Waste Facility located in Odanah, Wisconsin.
- II. Project Administration: The Bad River Band of Lake Superior Chippewa Indians is the Owner for this project. The selected firm will contract directly with the Tribe for the purchase of the equipment.

Quotes for the equipment are due no later than **10:00 am (local time) on Thursday, March 12, 2026**. Quotes can be mailed or hand-delivered in a sealed envelope with the words "Solid Waste Equipment" clearly written on the outside and are to be sent to the following owner's contact:

- III. Description of Equipment: The provided equipment will be evaluated and awarded based on available funding. The bidder/dealer shall provide pricing on the attached bid schedule for a base bid and add-alternate items as follows:

Schedule A – Garbage Truck

The base bid shall include an 8 cubic yard garbage truck as listed below. All equipment provided shall be new, of the current production model, and conform to the latest SAE/ISO standards. Base bid includes:

Garbage Truck: The truck shall be rated for the following specifications and shall be equal to an Isuzu NRR Rear Loader Garbage Truck with Cart Tipper (non-CDL).

- a. Engine
 - i. 200 HP min with Exhaust Brake
 - ii. Engine Block Heater
- b. Transmission
 - i. Automatic Transmission
- c. Cab and Chassis
 - i. 30-gallon Stainless Steel Fuel Tank
 - ii. Power Windows & Door Locks
 - iii. Air Conditioning
 - iv. Two Occupant Fold Down Bench Seat
 - v. USB Bluetooth Radio with Aux Input
 - vi. 140 AMP Alternator, 2 Batteries – 750 CCA
 - vii. Battery Disconnect Switch
 - viii. LED Strobe Bar on Top of Single Cab (hard wired to toggle switch inside cab)
- d. Rear Loader Body
 - i. 8 Cubic Yards with 1 Yard Hopper
 - ii. Center Mounted Cart Tipper
 - iii. 30-gallon Hydraulic Oil Reservoir
 - iv. Dual Strobe Lights – Rear End of Truck
 - v. Hopper Work Lights

- IV. Basis for Award: Award will be made to the lowest quote from a qualified bidder/dealer. Note – Owner will consider whether the quotes comply with the prescribed requirements, and such alternates, prices, and other data. Owner may conduct investigations as Owner deems necessary to establish the responsibility and qualifications of bidder/dealer.

- V. Basis for Payment: Awarded bidder/dealer will be paid once equipment has been procured and delivered to the Owner. Quotes received shall include all costs

associated with the procurement and delivery of the equipment to the Owner at the Solid Waste Facility, 69133 US Hwy 2, Odanah, WI 54861.

- VI. Contract Times: The contract award shall be given as soon as possible after quotes have been received and reviewed.

Equipment shall be delivered to Owner no later than June 1, 2026.

*In the event an attachment or multiple attachments have longer lead times, please provide estimated delivery times so the Solid Waste Dept. can plan accordingly.

- VII. Bidder Qualifications: Dealerships submitting quotes shall be authorized representatives of the manufacturer and capable of completing service and warranty work on the equipment provided.
- VIII. Information to be Provided with Quotes: Dealerships providing quotes shall provide enough information, along with quotes, to ensure that equipment being supplied meets or exceeds the specifications/features/requirements listed above.
- IX. Additional Information: Owner is a federally-recognized Indian tribe and is exempt from the payment of sales tax of any type (federal, state, local). Quotes shall NOT include sales tax. The tax exempt certification will be provided upon request.

To Whom It May Concern:

The Bad River Band of Lake Superior Tribe of Chippewa Indians is an Indian Tribe organized under Section 16 of the Indian Reorganization Act of 1934, 25 U.S.C., Section 476. Controlling case law immunizes the Tribe from taxation. Bryan vs. Itasca County, 426 U.S. 373 (1976). The Tribe does not possess a tax exemption number because Indian Tribes are not taxable entities from which exemption must be requested. See Rev. Rul. 67-284 (modified on other grounds by Rev. Rul. 74-13).
