REQUEST FOR PROPOSALS

Chef for Spring Feast

Bad River Band of Lake Superior Tribe of Chippewa Indians is seeking proposals through solicitation for:

- Preparing and cooking traditional Anishinaabe foods for a community Spring Feast, approx. 75 plates
- Utilization of traditional, wild harvested foods provided including, but not limited to fish (walleye), wild turkey, ramps/wild onions, fiddleheads, nettle, maple syrup
- Must be available in late May. Dates flexible from May 28th – 31st

Proposals are required to contain the following information:

- Description of meal ideas utilizing above foods. Please provide dish ideas and preparations of traditional foods listed above.
- Relevant experience cooking with indigenous foods
- Availability in late May.
- Total Cost

The Bad River Band of Lake Superior Tribe of Chippewa Indians is a federally recognized Indian Tribe organized under Section 16 of the Indian Reorganization Act of 1934, U.S.C. Section 476. This entitles the Tribe to government pricing and exempts the Tribe from state sales and use taxes and from federal excise taxes. Therefore, price quotations should not include such taxes.

This Request for Proposals is open to all qualified, responsive bidders. Indian Preference will apply in the selection process in accordance with the Tribal Employment Rights Ordinance (TERO) or the Indian Preference Act of 1934 (Title 25, USC, Section 47), based on funding source requirements. Firms or persons applying for Indian preference must provide evidence in its proposal of 51% or more Indian ownership. In addition, the firm or person must provide evidence of structure, management and financing affecting the Indian character of the firm. Documentation of and compliance with Indian Preference must accompany the proposal.

Sealed bids must be labeled “**Chef for Spring Feast**” and submitted by **Tuesday, May 19th, 2026 by 4:00pm.** Proposals should be directed to:
