The Bad River Indian Reservation land and its waterways are significant historic properties to the Bad River Tribe, as those properties are: 1) associated with events that have made a contribution to the broad patterns of United States history; 2) associated with Chippewa Chiefs who were significant in Treaty negotiations with the United States; 3) located in a district where a unique Tribe customarily continues with ancient societal practices, traditions, beliefs, lifeways, arts and crafts, and such activities are reflected in their modern day lives; 4) may likely yield important information from an era previous to European contact, to enhance the history of the Bad River Band of the Lake Superior Tribe of the Chippewa.

Since there is no evidence of an archeological survey being conducted to the standards of today at the time of \_\_\_\_\_, we require \_\_\_\_ Tribal Monitors on each ground disturbing activity to observe for archeological anomalies.

Should an inadvertent discovery occur, all activity within the area must cease and the THPO contacted immediately to mitigate impacts of the discovery and determine placement of discovered human remains/items. We also require that the company/agency hire a registered professional archeologist (RPA) to be available in the event of an inadvertent discovery, who is qualified in bone identification and that their qualifications are reviewed by the THPO.

The Bad River Tribe has a *no removal* policy for inadvertent discoveries within the exterior boundaries of the reservation, in accordance with our *Tribal Repatriation Policy*; Tribal Council Resolution #12-16-09-141. The Bad River Tribal Repatriation Committee will address those protocols, in the event of an inadvertent discovery.

If previously undisturbed areas are disturbed, we require a flat blade is used on excavation equipment with low treads, and that 2" incremental scraping takes place for Tribal Monitors to observe for archeological anomalies that may indicate a burial is present. \_\_\_\_\_ shall be liable for all required contractors while on their job site.
